NOTIFICATION

No. F 07-24/2018/32. In exercise of the powers conferred by sub-section (1) of Section 85 read with sub-section (3) of Section 24 of the Chhattisgarh Nagar Tatha Gram Nivesh Adhinyam, 1973 (No. 23 of 1973), the State Government, hereby, makes the following further amendment in the Chhattisgarh Nagar Tatha Gram Nivesh Niyam, 2020, namely:-

AMENDMENT

In the said rules,-

1. In sub-rule (1) of rule 18, after the words and symbol "in Form-XV of these rules", the words and symbol "through electronic process (online mode) or offline" shall be inserted.
2. In sub-rule (3) of rule 18, for the protasis, figure and symbol "shall be deposited with challan in Main Head-0217 Urban Development Plan Town and Country Planning and the original or attached copy of challan of receiving such payment shall be attached with the application", the protasis and symbol "shall be deposited through electronic process (online mode) or offline in Main Head-0217 Urban Development Plan Town and Country Planning" shall be substituted.
3. In clause (a) of rule 19, after the words and symbol "in Form-XVI", the words and symbol "through electronic process (online mode) or offline" shall be inserted.
4. In clause (b) of rule 19, after the words and symbol "in Form-XVII", the words and symbol "through electronic process (online mode) or offline" shall be inserted.
5. In Form-XII, for the words and symbols "The Secretary, Government of Chhattisgarh, Housing and Environment Department, Mantralaya, Mahanadi Bhawan, Nava Raipur Atal Nagar", the words and symbols "Director, Directorate Town and Country Planning, Indrawati Bhawan, Nava Raipur Atal Nagar" shall be substituted.
6. In Form-XIII,-
 - (a) for the words and symbols "Secretary/Special Secretary/Joint Secretary/Deputy Secretary, Government Of Chhattisgarh, Housing and Environment Department", the words and symbols "Director, Directorate Town and Country Planning, Indrawati Bhawan, Nava Raipur Atal Nagar" shall be substituted; and
 - (b) for the words "by the State Government", the words "by the Director" shall be substituted.
7. In items number 4 of Form-XV, for the protasis, figure and symbol "with challan in Main Head-0217 Urban Development Plan, Town and Country Planning and attached its original or attested copy", the protasis and symbol "through electronic process (online mode) or offline in Main Head-0217 Urban Development Plan Town and Country Planning" shall be substituted.
